## INVITATION TO BID FOR SUPPLY AND DELIVERY OF LIVESTOCK & COMMERCIAL HOG FEEDS FOR THE IMPLEMENTATION OF SUSTAINABLE LIVELIHOOD SUPPORT FOR DISASTER AFFECTED AREAS.

The *Department of Agrarian Reform Camarines Sur 1 Provincial Office*, through the General Appropriations Act (GAA) of 2018 intends to apply the sum of *Three hundred ninety six thousand pesos (Php 396,000.00)*, being the Approved Budget for the Contract (ABC) to payments under the contract for the supply and delivery of livestock and commercial hog feeds. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The *Department of Agrarian Reform Camarines Sur 1* now invites bids for the aforementioned Contract. Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

Interested bidders may obtain further information from the BAC Secretariat and inspect the Bidding Documents at the address given below during office hours from 8:00 AM - 5:00 PM.

A complete set of Bidding Documents may be acquired by interested Bidders on *May 9, 2018* from the address below *and upon payment of Five hundred pesos (500.00) per lot*. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
