SEPTEMBER 21 ARRIVE JOHANNESBURG

On Arrival at Johannesburg airport you will be met and transferred to your hotel.

Accommodation: Southern Sun Katherine Street Sandton, standard room - 2 nights

SEPTEMBER 22 JOHANNESBURG (BL)

After breakfast at the hotel you will have a full day Soweto and Apartheid Museum Tour. Drive by Mandela House, and see Regina Mundi Church. Regina Mundi Church is the largest Roman-Catholic church in South Africa. Visit Hector Pieterson Museum commemorates the role of the country's students in the struggle against apartheid. The site is just blocks away from where 12-year old Hector Pieterson was shot in 1976. Lunch is included at Sakhumzi's Restaurant.

This afternoon you will visit the Apartheid Museum, the first of its kind, illustrates the rise and fall of apartheid. The museum is a superb example of design, space and landscape offering the international community a unique South African experience. The exhibits have been assembled and organised by a multi-disciplinary team of curators, film-makers, historians and designers. They include provocative film footage, photographs, text panels and artefacts illustrating the events and human stories that are part of the epic saga, known as apartheid. A series of 22 individual exhibition areas takes the visitor through a dramatic emotional journey that tells a story of a state-sanctioned system based on racial discrimination and the struggle of the majority to overthrow this tyranny. For anyone wanting to understand and experience what apartheid South Africa was really like, a visit to the Apartheid Museum is fundamental. The museum is a beacon of hope showing the world how South Africa is coming to terms with its oppressive past and working towards a future that all South Africans can call their own.

SEPTEMBER 23 HAZYVIEW (BD)

Breakfast at the hotel. Depart by 7:30am and transfer overland to Hazyview. This afternoon enjoy an open-vehicle game drive in Kruger Park. Tonight enjoy a Shangaan River Club – cultural show and boma dinner (subject to availability).

Hippo Hollow has one of the most spectacular settings in Mpumalanga, situated on the banks of the Sabie River, just 2km outside Hazyview and 35 minutes from Kruger Mpumalanga International Airport,

SEPTEMBER 25 ARRIVE IN CAPE TOWN (B)

Breakfast at the hotel and this morning you will transfer to Kruger Mpumalanga airport in time for your flight to Cape Town (not included). On arrival at Cape Town airport you will be met and transferred to Table Mountain with your ticket included. (weather dependant) Transfer to your hotel for overnight the next five nights on a bed and breakfast basis.

With its majestic Table Mountain backdrop, Cape Town is one of the most beautiful and exciting cities in the world; an eclectic mix of architectural styles reflects the tastes and dictates of the past and the more functional demands of the 20th Century. Cobblestone streets, mosques and the flat roofed pastel homes of the Malay quarter enhance a cosmopolitan ambience and in a recent development, the restoration of the Victoria and Alfred Waterfront evokes images of the seafaring activities of the 19th century. At the end of the day, gourmets and lovers of sophisticated entertainment have a treat in store as the choice for your evening's repast is vast.

SEPTEMBER 26 FULL DAY WALK TO FREEDOM TOUR (B)

Enjoy breakfast at the hotel ad begin your full day Walk to Freedom tour.

'No easy road to freedom' was a central theme in most of the Mass Democratic Movement's campaigns, from the early days through to the late 1980s. Any understanding of present day conditions in South Africa is greatly enhanced by looking at past injustice, the legacy of the struggle and the promise of reconstruction and development initiatives under way at present. This Cape Town day tour offers a wealth of insight into South Africa's history. It includes a brief education introduction to Cape Town, one of the world's most varied and popular cities.

As a result of the Group Areas Act, 60 000 Capetonian families were forcibly removed from this once

vibrant area between 1966 and 1982. The District Six issue remains crucial. You will examine the now desolate area, Zonnebloem, which was District Six and visit the living museum which attempts to represent and recapture District Six in various ways - as a finespun tapestry of communal life torn apart but not forgotten.

Langa & Khaylelitsha Townships

Seeking racial segregation, apartheid policies disrupted all non-white population groups, distorted both rural and urban development and ensured hopeless overcrowding. Few houses were built. Sprawling satellite camps of seemingly endless 'shanties' (makeshift structures of various materials) - provide little more than a roof and some shelter. As you shall see, squatter settlements are seeking their own solutions as an economic necessity. Against all odds, township life prevails, in all its nuances. As guests of local community workers, you will take a walk through a vibrant black community with all its different social strata. Langa is Cape Town's oldest formal black township. Visit the local market, the craft Centre and a traditional healer. In Kaylelitsha, experience life in a township. You will have the opportunity to talk to people and try the traditional African sorghum beer and ginger beer at the 'spaza' (a small township shop) or the 'shebeen' (tavern). Witness the work in progress as hundreds of squatters, with the help of state grants, are setting about building their own brick homes.

After your township tour, transfer to The V&A Waterfront for lunch (own expense). After lunch board your ferry to Robben Island.

Robben Island (weather permitting)

Please note that Robben Island has implemented a new procedure for all passengers booked on the Robben Island tour. Guests are required to show proof of passport/ ID and fill out an indemnity form before boarding the vessel to Robben Island. They may bring copies of Identification should they wish to rather keep the original at the hotel.

Formerly a political prison and leper colony, before that, this historic landmark was recently established as a museum and national monument. On this leg of your Cape Town day tour you will experience the conditions of incarceration - view Nelson Mandela's maximum-security prison cell (Cell 5) and see the lime quarries. Former inmates lead tours around their old cells - a moving experience for both them and thousands of visitors from around the world. This well-preserved landmark is a monument to the triumph of freedom, dignity and determination over humiliation and oppression.





Return to your hotel for overnight.

SEPTEMBER 27 FOODIES ON FOOT TOUR (BL)

Breakfast at the hotel followed by a Foodies on Foot tour. (Monday-Saturday 10:00am-1:0pm) Sample the flavours of Stellenbosch, a 335 year old university town, known as the City of Oaks or Eikestad in Afrikaans and Dutch due to the large number of oak trees that were planted by its founder, Simon van der Stel, to grace the streets and homesteads... You'll enjoy top quality, locally produced artisan food during a leisurely walk. And along the way you'll get to meet some of the passionate food artisans of this beautiful town.

After your tour you will transfer to Stellenbosch wine estate for a wine tasting.



Return to your hotel for overnight.

SEPTEMBER 28 CAPE MALAY COOKING SAFARI (BL)

Breakfast at the hotel and begin your Cape Malay cooking safari. (9:00am-1:00pm)

Get to know aspects of the cultural diversity that Cape Town has to offer on this interactive guided walk through the historical heart of the Bo-Kaap with a mini shopping safari. The focus lies on the Cape Muslim people with their South-East Asian heritage, their culture, their community and their food and links between these. Stop at a local spice shop and halaal butcher, interacting with locals and discovering typical Malay ingredients. The highlight? Visit a local family's home and participate in a hands-on funfilled cooking session and demonstration before savouring a full traditional lunch!

Transfer back to the hotel and the afternoon is at leisure.

SEPTEMBER 29 DAY AT LEISURE (B)

Breakfast at the hotel and the day is at leisure to enjoy the city or any optional touring.

PASSPORT & VISA INFORMATION*:

Please ensure clients have arranged all documentation with the appropriate consulate well in advance of their departure from the US and that passports are also valid for the minimum validity required for **ALL** destinations being travelled to. The information following only applies to the itinerary booked with Goway Travel and does not cover any independently arranged destinations.

I. **PASSPORTS**

Please ensure you have the correct documentation with you ready for check-in, security clearance and the boarding gates. For international travel, government regulations require all travelers over 16 years old to be in possession of a valid (return) air ticket, a passport and visa and health documentation (if required). Travelers without the necessary documents will be not be allowed to board to avoid flouting immigration rules. It's important to note that non-South African passport holders must have at least two (1) completely unused visa page for entry or departure endorsements by South African Immigration Service in their passport. Government regulations prohibit airlines from boarding travelers without the required blank visa pages, even if you hold a valid ticket and a valid passport. Please note that if you are travelling to other countries, you will need additional blank pages

TRAVELLING WITH CHILDREN TO SOUTH AFRICA

New requirements, introduced by the South African Department of Home Affairs from 1 June 2015, specify that all minors (children under 18 years) are required to produce, in addition to their passport, an Unabridged Birth Certificate which shows the details of both parents for all international travel to and from South Africa. Further documentation may be required. Travelers will be asked to produce the required documentation at check-in for each flight.

Visa requirements applicable to this quotation are as follows: At the time of this quotation, there is no visa requirement to South Africa for American citizens. Clients are required to have two consecutive blank pages in their passport for South African arrival documents or they will be denied travel. For Zimbabwe and Zambia a univisa can be purchased.
