STORM WATER FILTER VAULT MAINTENANCE PROJECT SCHEDULED

Davidson-Macri Sweeping, Inc. will be starting this project on 7/23/18 and complete it on 7/27/18. It includes filter replacement and associated maintenance in the north and south vaults. These are located in the park on 56th Ave NE in the planting beds near the mailbox and sidewalk.

The east side of 56th AVE NE will be posted a NO PARKING ZONE to facilitate the equipment and reduce foot and vehicle traffic close to where the work is in progress. The mailboxes will be kept clear for delivery and pick up of mail. It will be very noisy and you should avoid this area of the park and sidewalks during work hours 7:00 AM – 3:30 PM. 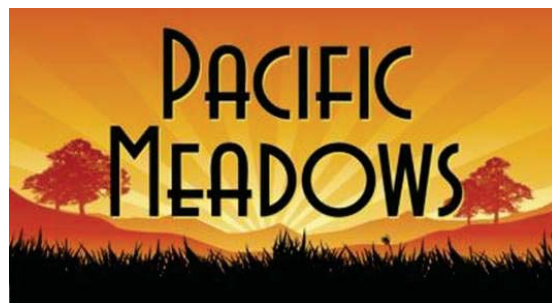
