Art. 1 - Object of the General principles

This document describes common rules and values of the "International Joint PhD program in Plant Health in Sustainable Agriculture (PHiSA)" (hereinafter: PHiSA).

Art. 2 - Objectives

In addition to the general objectives of the PhD programmes, outlined in the partner universities regulations, PHiSA has the specific objectives of training students to attain advanced professional skills and autonomy, and to assume direct responsibilities in their academic, scientific and research activities in the field of plant protection, based on sustainable ecological approaches.

Art. 3 - Areas of scientific research and study disciplines

The six focus scientific areas of PHiSA, as defined in the project proposal, are "Diagnosis in plant health and IPM", "Sustainable use of pesticides", "Plant feeders", "Plant Pathology", "Weed science", and "Mycotoxins and food safety" together with general contents of transversal interest. The learning outcomes of each focus area and the separate study disciplines are defined in the Curriculum description.

Art. 4 - General characteristics

PHiSA lasts at least three years (180 ECTS). It can be prolonged according to the national local rules of each partner University.

A call for the public selection of candidates is issued each academic year. The call indicates the number of students that could be enrolled and scholarships available for each partner University.

The admission notice at the selection is published on the website of each partner University.

The most qualified candidates, irrespective of gender, age, nationality, religion, ethnicity, and social class are admitted to PHiSA.

The official language of PHiSA is English. The selection process, implementation and thesis defence are hold in English.

Art. 5 - PhD program bodies

The bodies of PHiSA are: i) International Board and ii) International Coordinator.

i) The International Board is composed of representatives from the Consortium partner universities, that hold scientific-teaching title in plant health plus one PhD student elected among the admitted students.

The duties of the International Board are:

- a) to define guidelines for didactic and scientific activities;
- b) to evaluate, at the end of each year, the diligence and the progress of the research of each PhD student on the basis of a written report and an oral presentation by the PhD student himself.

The International Boards' meetings can be held only if there are half plus one of its members present. Meetings can make use of multimedia tools. Decisions are taken with the favourable vote of the majority of all members. The coordinator's preference prevails in case of a tie vote.

ii) The International Coordinator is elected by the members of the International Board. After the election he/she is appointed by the Rector of the respective partner university.

The International Coordinator holds a scientific-teaching title in plant health and is involved at each level of education at home University.

The duties of the International Coordinator are:

- a) to organize, supervise and coordinate the functioning of the Joint PhD Program in cooperation with the International Board
- b) to call sessions and to preside over the International Board.

Art. 6 - Elections of the PhD students in the International Board

The representation of the PhD students in the International Board consists of one PhD student per admission cycle. The International Board appoints an electoral commission, which organizes the elections. The Commission convenes the PhD students for the presentation of the candidacies and the votes which will be done also using digital tools.

Art. 7 - Supervising

The representative in the International Board of each partner University identifies at least one local supervisor for each PhD student assigned to its seat and proposes at least one supervisor selected among the partner University professors.

The International Board proposes and confirms the international supervisors.

The supervisor has the task of following and guiding the PhD student in his/her didactic and scientific training. The supervisor informs the representative of the partner university in the International Board about advances in the research activity and on any problems and needs related to the research itself, as well as on the proposal for authorization to carry out part of the research activity of the PhD student abroad.

The representative of each partner university in the International Board may write a proposition to revoke the appointment as supervisor if he/she does not comply with these obligations. Further steps of supervisor revoking process are in accordance with local rules.

Art. 8 - Requirements and procedure for admission to the PhD program

The admission to the PhD program is allowed to candidates with a minimum of 300 ECTS (or more) degree and provided with a documented C1 (according to the Common European Framework of Reference for Languages: Learning, Teaching, Assessment) or higher level of English language.

Criteria for the selection of the candidates:

- to have at least average grade (according to national rules at each partner University) at bachelor and master studies,
- to have background in natural, biotechnical or other science fields related to PHiSA,
- an advantage is if the candidate has a project related to PHiSA,
- the qualification of the candidate can be evaluated by an interview with the International Board.

Art. 9 - PhD program structure - Training activities

Six focus areas related to plant health are proposed in the study programme (as described in the curriculum).

Training activities for PhD students are divided into educational activities (minimum 28 or workload equivalent and maximum 60 ECTS or workload equivalent) and research activities (minimum 120 ECTS or workload equivalent and maximum 152 ECTS or workload equivalent). The educational activities are composed of mandatory disciplines (10 ECTS or workload equivalent) and disciplines on topics chosen from one or more focus areas (20-50 ECTS or workload equivalent). Mandatory disciplines are in common for all students. All other topics are grouped in the focus areas and are elective. Students choose them based on their research interest taking care to collect minimum 20 ECTS or workload equivalent.

The training in mandatory disciplines will be preferably organised by concentrating the activities within a week, choosing and selecting the most current and relevant topics, each time defined by the International Board.

Training at distance can be allowed.

The research activities count between 120 and 152 ECTS or workload equivalent and are composed of experimental work, presentation of the results, preparation of the thesis as it is defined by criteria set up by the International Board.

Art. 10 - Educational and research activities abroad

The PhD student carries out training periods abroad in public or private institutions for research needs related to the PhD project for at least six months, also non-continuative. The period is authorized by

the representative of the partner university in the International Board for at most six months and by the International Board for more than 6 months abroad. Exceptionally, PhD student may carry out the period in the home country, outside home university, in an institution recognized by its high scientific-research excellence, but it must be approved by the International Board. This period may not exceed 18 months.

Art. 11 - Evaluation of the PhD student for admission to the following years

The PhD student confirms or emends the research project or narrow scientific field within three months from the beginning of the PhD program. If the candidate selection is done based on a research project, this requirement is already met.

The admission of the PhD students to the following years is subjected to:

a) the regular attendance of the activities of the PhD program. This activity, equal to 60 ECTS per year, is verified by a daily register of the activities filled by the PhD student, which is signed by at least one supervisor and by the representative of the respective partner university in the International Board or based on local rules;

b) the positive evaluation of the annual activity of the PhD student. An intermediate assessment might be foreseen at the end of the first semester of each year of the PhD program, when the PhD student is required to present a short written report on the activities carried out until that time. At the end of each year of the course the PhD student is required to present a detailed written report and a brief oral presentation concerning the activity carried out so that the International Board, based on the opinion of the Supervisor, evaluates the diligence and the progress of the research in order to, in accordance with local rules, admit the PhD student to the next year.

The status of a student, or any change of its status at the PhD program, is regulated in accordance with the national rules at each partner University.

The application of the topic of the doctoral dissertation is conducted in accordance with the national local rules at each partner university. Student reports a topic after coordination with the supervisors. Doctoral dissertation topic report must contain at least:

- A) Proposal of Doctoral Dissertation Topic
- B) Explanation of the Topic
- C) Methodology of work
- D) Expected scientific contribution.

Art. 12 - Evaluation of the PhD student for admission to the thesis defence

The evaluation of the PhD student for admission to the thesis defence is conducted in accordance with national local rules at each partner University.

Art. 13 – Language of the PhD thesis

The PhD student writes the thesis in English. The thesis is accompanied by a summary in English and in the local language of the partner University.

Art. 14 - The PhD thesis defence

Evaluation of the PhD thesis is conducted in accordance with national rules at each partner University.

The final exam consists in the presentation and public discussion of the PhD thesis. At the end of the discussion, the Commission approves or rejects the thesis. It is at the discretion of the Commission, with a unanimous vote, to award the title with honours in the presence of results of particular scientific importance. The home University ensures the publicity of the assessment procedures, including the opinions on the individual candidates. The PhD Diploma is issued by the Rector who, at the request of the interested party, certifies its achievement.

Art. 15 - Rights and duties of the PhD student

Rights and duties of PhD student follow the national local rules of each partner University.

Art. 16 – Supervising activities, integrative teaching and compatible activities

As an integral part of the training, the PhD student can perform teaching activities in the form of tutorials in accordance with the rules of the home University. The teaching activities must be compatible with the PhD program training activities and may be awarded to second- and third-year PhD students.

Art.17 - Collision of the General Principles and Local rules

Any matter which is not regulated or defined by these General Principles shall be deemed to have been regulated by legal acts of partner universities. In case that certain provisions of these General Principles are in collision with the mentioned local rules, the latter will be applied.

Art. 18 - Referral rules

This regulation follows European Charter for Researchers and a Code of Conduct for the Recruitment of Researchers (European Commission 21620) as the joint rule set up in the EU's policy to boost researchers' careers. This regulation integrates, as expressly provided for by this, the provisions of the current national legislation, which find full and direct application in any case.

Art. 19 - Agreements among the partner Universities

The procedure for carrying out a co-supervised doctorate requires the signing of a doctoral co-tutorship agreement, which has individual research validity and the issue of the title.

The co-operation agreement is prioritized by the signing of a Framework Agreement between partner universities, which has general validity and contains a brief description of the areas of scientific-disciplinary collaboration.

Art. 20 - PhD degree

The co-protection path of the PhD program involves the alternation of an approximately equivalent research period in two universities between which an agreement is entered into. At the end of this process, a double qualification degree is issued which is valid in both countries.

The diploma will be issued by two institutions: home institution where the candidate is enrolled and partner University from which the second supervisor is based. Rectors of both institutions are assigned to award the student with the diploma and promotion will take place at home university.

Art. 21 – Emendation to the current General Principles

The regulation can be modified, unless the modification entails modifications to the regulation which would violate the principle of equal treatment of signatories.

The amendments can be requested by any signature of this regulation.

The changes will be approved by unanimous vote.
