On the first part:

- hereinafter referred to as – the Company (member)

On the second part:

Pierre Calleja passport no MLT 902011 Director of NLCS International (Malta Office) hereinafter referred to as Consultant.

And whereas the Consultant has been appointed by the Company member and there services described in Schedule A hereto annexed and forming an integral part thereof

And whereas the said Services shall be supplied at the price quoted direct to the Businessman ( Buyer, Clients./ or Government Tender)

Now therefore, this agreement is being made subject to the following terms and conditions:

- 1) According to this agreement, the Consultant will act as an exclusive Consultant for the Company member for the foreign market.

- 2) NLCS Malta Office through its Agents, will do its utmost to introduce Businessmen interested in the Services offered by the Company member for future business relations.
- 3) NLCS Malta Office will introduce the Company member, to Foreign clients (indicate in paragraph 1A) who will be interested in

the Service Of the said Company . NLCS will act only as witness and Consultant and all decisions will be taken by the Company member and the clients. Any payment agreements will be done by the Company and the clients.

- 4) The Consultant shall be entitled to receive a Ten per cent (10%) commission calculated on the whole price (Face Value)
- 5) The Company member presently wants to submit:
  - *A : Signed agreement*
  - *B : Company Profile*
  - *C: Administration fee of 600 Euros. payable only once.*
- 6) Commission payable to the consultants will be paid not later than 20 days after the Company member is paid by the clients.
- 7) It is at the discretion of the parties to decide on whether the modality of payment for the remaining balance shall be paid at once or pro rata to the services by the Company member to the Customer/ Client
- 8) This agreement shall be regulated by Maltese Law and the parties undertake to subject themselves to the exclusive jurisdiction of the Maltese Courts/Tribunals in case of dispute
- 9) This agreement can be terminated by the Company member any time it seems fit before any work is done in Libya. and 1year after last works. Once introductions with NLCS clients or with our Team from the Consultant start, the contract will be binding for both parties and cannot be terminated. and if the company member sell the shares to another company (we will need to know who the new owners are) this commission agreement will automatically be transfered on the new owners.
- 10) This agreement, including the Schedules hereto, constitute the entire agreement between the parties relating to the subject matter hereof, and except as stated herein or in the instruments and documents to be executed and delivered pursuant hereto, contain all the representations and warranties of the respective parties relating to the subject matter hereof.
- 11) A copy of any contract, invoice and cash sale that are issued between the Company member and the Client must be given to the Consultant.

12) The Consultant agrees that it will not hold itself out as a partner, joint venture, co principal or employee of the Company member by reason of this Agreement. But to represent them in the foriegn Markets. Marked in clouse 1A

13) This agreement is for the Private Business & Govermental Sector.

14) If Companies will be required to work together on large projects, we expect co operation from all companies.

15) All of the company workers must respect the consultants or there representatives.

16) If you will require a visit to Libya and would like the consultant to accompany you to talk with foriegn Businessmen for possible business ventures, all expenses (air ticket, accomodation etc) for this visit for the consultant must be paid by the Company member. If more than one company takes part on the same trip, then the expenses for the consultant will be split equally by all the companies taking part. But if the company members prefers to go alone with the consultant, then the consultant will accompany it too.

17) For Goverment projects the Company will be notified by the tender winner.

18) Anyone going to work in foriegn country must respect the Laws. NLCS will not be responsible for anyone breaking the law.
