Your Excellency,  
Most Hon. Andrew Holness,  
Prime Minister of Jamaica,

I wish to use the opportunity which you have created for organizations to receive messages from you to seek protection for Goals Of Angels Church. I am the founder of the church. I am requesting you to send a message of protection for all members of my church so that we will gain safety wherever we are. My presentation is numbered one to seven in order to conform with the guidelines for requesting messages from you.

1. The fundamental goal of my church is to preach the word of God. To count my achievements, I have designed a website for the church. The URL is <http://www.worshipinspirit.org> . I have also done name search and reservation through the Nigerian government agency known as Corporate Affairs Commission. The formation of the church dates back to 11th November, 2010 . The full history is uploaded below.

2. The message which I will receive from you will be published on the church website. I will celebrate your message on 3rd January, 2022 . I have chosen this date to meet the four week timeline. The theme of the celebration will be JAMAICAN PRIME MINISTER'S PROTECTION. Being alone in the church, I have scheduled publication of your message on the church website as the ultimate activity. I will write praises and attach to your message on the website. There were people who liked the Facebook page of the church before it was deleted. I will find them for membership registration. I will find other people as well. When the church gets members, we shall celebrate JAMAICAN PRIME MINISTER'S PROTECTION yearly.

3. The message should be sent to me. I am the founder of the church. My name is Myina Ivyarave. My email address is theocracy@yahoo.com where I have contacted you now. My telephone number is 07011055711. I do not have a postal address and fax.

4. I will use your message on my church website to boast of protection. I will show to Nigerian armed forces and other government agencies when I travel to other countries.

5. I propose that the name of your message should be MY EYES ARE ON YOU. I CARE FOR YOU. The name implies that you, the Jamaican Prime Minister, will give us confidence that you will watch and care for us. I will publish your message on the church website, <http://www.worshipinspirit.org> , on 3rd January, 2022 as soon as I receive it.

6. I will circulate your message to people who plan evil against me and put them to shame. Let me cite an example. I went to a cyber cafe yesterday, 29th November, 2021 around 12noon and printed guidelines for requesting messages from you. I saved the print-out in a notebook and held in my hand. Later around 3.00p.m. , a lady appeared to me while I walked on the road towards Karu Market and accused me of owing her twenty thousand naira. She said I borrowed the money from her in the first week of November, 2021 . She gave false identities about me claiming that I

worked in an oil company, I had a car and a certain phone number. I denied but she beckoned to thugs and they surrounded me. Seeing that she worked at a P.O.S. unit nearby, I told her that bankers generally use CCTV and she should confirm her words electronically. Those thugs were angry at hearing the term "CCTV" and started hitting me with rods. Some money was removed from my pocket. Police came to intervene but it was difficult. I was taken to Karu Police Station. The police established that those identities given about me were false. However, the lady was permitted to go away respectably. She was not punished. She was not asked to compensate me. Five hundred naira was still taken from me to pay the cyclists who conveyed the lady, the police and me.

I hereby appeal to you, the Prime Minister of Jamaica, to use devices such as telescope to locate that lady and all people who used rods to disgrace me. All of them should be killed. Videos of their deaths should be given to me to publish and eliminate the disgrace they brought to me. Nigerians have done such things to me many times in the past. I always suspect that they are sponsored by Muhammadu Buhari, Gabriel Suswan, Samuel Ortom, George Akume and others.
