**Holding Agreement:** A non-refundable deposit of 200\$ is required per kitten/cat. The selller assigns the buyer the guarantee that the kitten/cat will not be sold to any party other then the buyer as long as the buyer adhere to the picking up kitten guideline. The deposit is non-refundable and will be applied to the purchase price of the kitten when the buyer assumes physical possession of the assigned kitten. Deposit may be via cashiers check, money order, cash in person. Or via PayPal. Check can be made payable to Robert Mattox. Records will be kept to keep track of payments made and keep track of total. Kitten will not be considered sold until deposit is received. Remainder of kitten price will need to be paid in full before the kitten is released to the new home. Kitten/cats may be shipped out or picked up no earlier than 12 weeks of age only after full payment has been received. If kitten/cat should die before it is in the buyer's care, a replacement kitten will be given when available. **Buyer's Initials:** 

**Guarantee:** This kitten/cat is guarantee to be in good health, to the best of the seller's knowledge. If he/she wishes, the buyer has 72 hours, from the date of ownership in which to have the kitten checked by a licensed veterinarian. Failure to have cat/kitten checked by licensed veterinarian within 72 will void health guarantee. After 72 hour, of the health guarantee period, the seller cannot be held accountable for further diagnosis of bacterial or viral infection environment after leaving are care and are not a result of genetic or breeding. If there is problem that cannot be rectified. You may return the kitten to us. At your expense, on the day following the vet exam, along with a veterinarian's statement stating the problem. Upon the kitten/cat's return, it will be replaced with another. If one is not available the buyer will be placed first on the waiting list. ( Exclusion: This dose not include the presence of parasites and also dose not apply to health problems resulting from an injury or accidents due to the buyer's negligence), the following provisions will be honored. All medical expenses are sole responsibility of the buyer.

All kitten are vaccinated and treated for worm before leave. However, you need to be aware that these things can arise and that they are usually not serious ( even though seeing blood in the stool appears serious) and easily treated and we will not cover the treatment for them after they leave our possession.

Viral, bacterial cold or bloody stools (form of worms) which are easily treated and are not covered in the health guarantee as they are natural things kittens can pick up. Umbilical hernias also referred to as 'outie' belly buttons are also no covered in the health guarantee. Kitten are naturally risk for viral and bacterial colds, and worms, which is often brought on by the stress of a new home, new food, new people , or just a change in environment. The kitten/cat is guarantee against congenital defect up until it one year old . Should anything arise within this time due to a congenital defect, the kitten/cat will be replaced by one of the same quality and value when the next litter become available. The replacement will only be given if necropsy has been performed and certificate from a licensed vet is provided as proof of death. The cost of necropsy will be responsibility of the buyer.

**Buyer's Responsibilities:** The kitten/cat will not be denied needed veterinary attention. If the owner is unsure whether or not the feline is in need of medical services, veterinarian will be contacted, the situation explained, and the

veterinarian's advice will be contacted, the situation explained, and the veterinarian's advice will be acted upon. The buyer shall provide proper nutrition, vaccination, vet care, shelter and exercise. Also keep a Persian reference book on hand at all times to refer back to, please call with any questions, we what to help you.

The kitten/cat will not be allowed outside. The feline will also not be destroyed for any reason other than terminal illness or injuries approved by a veterinarian. If this cat is going to be into multi-pet household, the seller will not be responsible for any illnesses or vet bills that occur due to expose between the kitten/cat and other resident's pets.\

This cat will not be de-clawed, De clawing is an in human mutilation . It consists of amputation of the first knuckle. Weekly nail-clippings , nail cover, and gentle discipline along with the availability of a scratching post or mat will eliminate scratching problems.

This kitten/cat will be given the proper diet in the proper amount and will have fresh water at all times. Clean litter box will also be available at all times. This kitten/cat will receive frequent and kind human attention. Use logic when interacting this kitten/cat with other animals, stranger, young children.

In regards to hereditary defects, there are never any guarantee that the kitten would be free of genetic disorder from pass generations. But since we may not know if there are any potential weaknesses in a kitten, we believe that the diet and lack of vitamins can exacerbate these conditions if found. Therefore, by providing the kitten with quality food and supplements, we are hoping to reduce the chance of these potential weaknesses from hindering their quality of life, should this ever occur. **Buyers Initials:** 

**First Right Of Recovery:** If buyer is unable to care for or chooses to change his/her mind about caring for the kitten purchased, We retains the first right of recovery of the kitten at the buyer's expense. The buyer must notify Robert Mattox as to change in circumstances and give the seller first right to the kitten before any other action is taken. This includes and is not limited to selling the kitten to other buyer. Buyer agrees if this kitten is offered for sale or trade at anytime in the future, it will first be offered to seller. If the kitten is being sold it will be offered to us at a purchase price not to exceed the original price of the kitten and minis 200\$ nonrefundable deposit. A determination will be made within thirty (30) days whether or not we wish to purchase back the kitten. This kitten must never be sold to a pet store, broker, kitten mill, or surrendered to a shelter. Breeder must be notified immediately of problems that arise or if buyer cannot care for kitten anymore. **Buyers Initials:**

Breeder will not refund money in whole or part for any reason other than stated in the guarantee.

Buyer also certifies, by signing this agreement that he/she is not acting as an agent in this purchase, that the buyer will not resell the kitten to a kitten mill, commercial breeder, pet store or medical research facility.

We have the right to rescue this kitten if we find that it is being mistreated, neglected, or abused and you do not voluntarily return it. Also, any mistreatment, neglect or abuse of the animal automatically voids all guarantees give by us.

Breach Of Contract: In the event the purchaser is found to have violated any of these terms and conditions of this contract, the cat/kitten is to be surrendered unconditionally to the seller. Seller may reclaim physical and legal ownership of cat/kitten with or without due process of law for any breach of contract with no refund of purchase price, in the event the purchaser is found to have violated any of the terms of this contract, purchaser shall be liable to the seller for damages in the amount of two times the purchase price of the cat/kitten, plus expenses for veterinarian care upon return of cat/kitten to the seller, and all attorney, legal action, which may arise under the terms of this contract, will be brought in the county/city of breeder's residence. This document is a legal and binding contract. This contract is to be governed by the laws of the state of Missouri. Seller and purchaser signatures indicate full agreement and approval of all the about terms and conditions of this contract. There are no other conditions or guarantees, verbal or implied. No verbal deviations or additions are valid. No other warranties or guarantees are provided other than those specifically outlined above.

I acknowledge that this is a legal & blinding contract and have reviewed and agree to the terms listed above. The buyer will also maintain up to date vaccines, worming, and keep the kitten in humane conditions and provide proper food , water and shelter . Failure to follow the above contract completely will result in 'A Breach Of Contract' and shall make this contract null and void. This contract applies only to the original purchaser and is not transferable. When a deposit is received by us the purchaser automatically agrees to the terms of this contract even if both the breeder and the purchaser have not yet signed the contract.
