

Gayatri Brahmana Seva Sangham (GBSS) is launching Annual Financial Assistance Scheme for Education (AFASE) for Brahmin Students. Under this program, specific amount shall be given to the selected applicants as financial assistance for the academic year.

Objective

To extend financial assistance to the Children of Brahmins in their education—be it academic or Vedic, where required.

Scope

Only Children/dependents of Brahmins belonging to Andhra Pradesh and Telengana

General Eligibility criteria

- At the time of application, the Applicant should be pursuing studies/Vedic Education and necessary proof shall be furnished to the GBSS.
- ➤ The applicant seeking financial assistance, is required to be referred by one of the GBSS members.
- ➤ Applicant should submit filled-in application (Appendix A) along with necessary supporting documents.
- ➤ Applicants whose family's annual income from all sources is equal to or less than Rs.3 lakhs only apply for the assistance.
- > Should be pursuing a regular course in a School / College/ Institute / University or any Vedic Institution where free residence and instruction are extended.
- > Should have passed in all the subjects till previous year of study (i.e., students who do not have backlogs in their previous semesters / years are only eligible).
- > Selected Students are required to submit the marks list of the academic year for which assistance has been extended.
- > Application Should be verified and endorsed by above identified 3 members
- The applicant shall conduct himself in a manner that enhances the reputation of himself as also that of the Community at all times.

Screening Committee

A Committee comprising of three members to be nominated by the President/Secretary shall examine and verify the applications for recommending sanction of financial assistance to the applicant. A Bank account is a pre-requisite for e-transfer of the assistance. Applications so verified together with recommendations of the Screening Committee, shall be submitted to the President/Secretary for approval.

Guidelines for Funds Maintenance

- > A Separate Bank account will be opened in the name of the Treasurer and Secretary/President exclusively for the donations received for the purpose of the Education Fund.
- > Donations are accepted from members of GBSS as well as from outside Agencies/persons.
- > Donations received from members and non-members towards education fund should be strictly used for the purpose of educational assistance only. However, if the non-members donate their contributions to the GBSS without specifying the purpose, may utilise the same for other purposes as approved by the Committee.
- The entire amount available to the credit of the Education Fund along with the interest accrued thereon shall be utilised for extending the AFASE.
- List of the recipients of the AFASE will be announced on Ugadi every year and immediately the amount sanctioned will be e-transferred to the respective Bank accounts.
- Three members from the GBSS core team will be constituted to act as Screening Committee, who shall evaluate the application for further consideration.
- Proper record of all applications accepted/rejected, shall be maintained together with accounts and shall be available for audit if required.
- GBSS shall have the powers to dissolve the Scheme at any time and in such an event, before dissolution, shall identify the eligible applicants and extend them the assistance. In case the amount available the credit of the Fund is so less that it will not be reasonably sufficient for extending the assistance, the same shall be transferred to the GBSS account.

Application Procedure

- Application can be obtained from GBSS Core team
- Application Should be submitted to GBSS through any of its registered members
- > Applicant must provide all required documents along with the application
