- 1) The Buyer agrees to provide a life-long commitment, comfortable environment, prompt medical attention, proper grooming and responsible care. This includes keeping this Rabbit parasite free and up to date with inoculations, proper nutrition, which consists of a good quality professional feed given at regular intervals, and fresh water available always.
- 2) The Buyer promises to provide a safe environment for the Rabbit, and never allow the Rabbit to roam freely without proper fencing or supervision.
- 3) The Seller guarantees the Rabbit will be of sound health and temperament at the time of this sale and will not be held accountable for health or temperament issues after purchase.
- 4) If at any time the Buyer can no longer retain possession of this Rabbit, the Seller is to be notified and given first option of resuming full ownership of the rabbit for the Seller to locate this rabbit a new home. Refunds, if any, will be at the discretion of the Breeder/Seller. The Rabbit will be returned with all papers and medical records. Should any circumstances arise that affect the quality of life of this rabbit, the breeder/seller is to be informed so that they may participate in determining the future of the rabbit. The Breeder/Seller reserves the right to approve/prohibit any transfer of this animal to a third party. Under no circumstances will this rabbit be sold, leased, traded or given away to any pet shop, research laboratory, animal shelter or similar facility.
- 5) The Buyer agrees to contact the Seller immediately if any questions or concerns arise about the rabbit, such as housing, diet, health or training. The buyer agrees to keep the

- seller informed of any treatment as it occurs. This provides the Breeder/Seller with an opportunity to follow up on rabbits and gives us important feedback and information on the health or our rabbits for future generations.
- 6) Pedigrees will be given with the Rabbit or transferred to the Buyer immediately upon receipt of purchase. It is understood at the time of sale that this is a Pet/Show quality Rabbit and it is representative of its breed.
- 7) The buyer acknowledges that special coat care, conditioning, training, and feeding are necessary to produce a competitive English Angora in conformation and performance events and that this care and training is his/her responsibility.
- 8) The buyer understands that the 50% down payment on the rabbit is non-refundable under any circumstances.
- 9) The buyer agrees not to sue the seller and to pay all court or attorney fees incurred by the seller should any suit be brought against the seller regarding this Rabbit by any person. The buyer signifies acceptance of this condition by initialing here: \_\_\_\_\_\_ on \_\_\_\_(date)\_\_\_\_
