
WHAT WILL YOU LEARN?



Graduates with a finance background are in high demand. This Accounting and Financial Management degree course will prepare you for a career in areas such as accountancy, auditing, tax advisory, wealth management, banking, business development and organizational leadership.

As a future accounting and finance professional, you will understand the legal, ethical and efficient practices which are critical to the role.

Studying a range of core and advanced accountancy and finance modules, you will gain skills in analyzing, planning and decision-making. As well as gaining the knowledge to provide financial advice to public, private and third sector organizations.



This course will enable you to:

- Explore the challenges of operating in a contemporary business environment and how new digital technologies are driving change
- Develop advanced skills in key areas such as management accounting and financial reporting – getting to grips with contemporary accounting information systems,

- Explore the legal environment within finance, financial crimes and the growing area of cybercrime.

In addition, you'll familiarise yourself with international accounting standards and gain detailed knowledge on the topics of investment analysis and portfolio management. Once you graduate, you'll have the skills to optimize corporate financial performance in a sustainable manner.





CAREERS: FINANCE CAREER OUTLOOK

Having completed Finance, you'll be a sought-after finance expert on the international market. Once you've completed your degree, you could work as...

As a risk manager, your job is to analyze business decisions with regard to their risks for the company. At a bank, for example, this means assessing the credit default risk before a lending decision is made. In the case of takeovers or mergers, you check whether they will actually result in the desired potential. And if a new product is to be launched on the market, you are responsible for a detailed competitive analysis. Your goal is always to identify and analyze potential risks and develop scenarios to minimize risks.

As a financial controller, your job is to measure the profitability of a company using key performance indicators. You uncover weaknesses, risks, and potential for improvement in the company and develop efficient solution concepts - often in cooperation with the specialist departments. If these concepts are implemented, you are responsible for the central recording and evaluation of the implementation progress and success and, if necessary, initiate adjustment measures.

Compliance officers have a controlling and supervisory function in companies. Your goal is to develop an organizational structure in which all employees can comply with legal regulations. You regularly inform employees about legal regulations and internal guidelines and initiate training in this area. You introduce adequate control mechanisms so that violations of regulations can be identified.
