



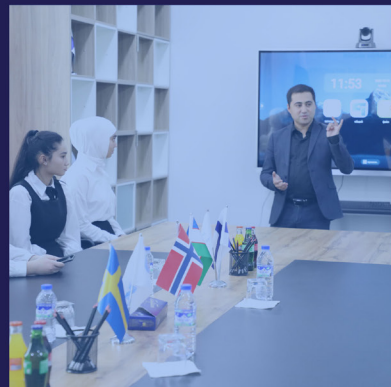

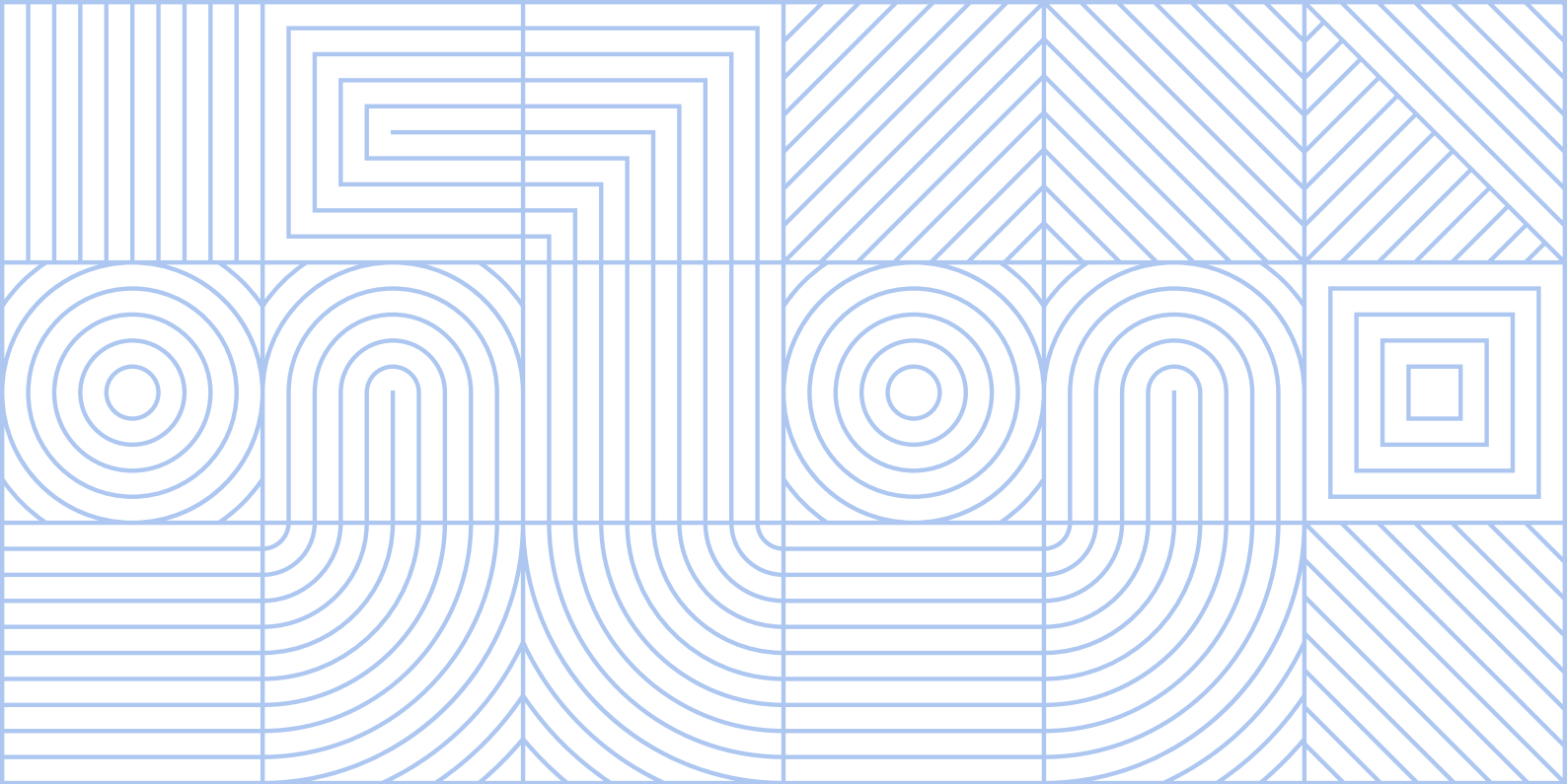

(70411901 - Master's Program in World Economy to applicants:)

Conducting scientific research works in foreign and local scientific research institutes, scientific research centers, design institutes, and scientific production associations;

Serves to increase the competencies for solving a number of complex issues related to the organization and management of international economic activity in the representative offices of Uzbekistan in foreign countries, international organizations and integrated associations, state organizations regulating foreign trade and foreign economic activity, and joint ventures with the participation of foreign investments.



## MASTER'S DEGREE STUDENTS IN THE WORLD ECONOMY DEVELOP PRACTICAL SPECIALIZATION SKILLS IN THE FOLLOWING AREAS:



- to understand the main causes and prospects of globalization of the world economy, and to assess the impact of globalization on the Uzbek economy
- Evaluation of the impact of the international financial market and institutions on the Uzbek economy; knowledge of the conceptual foundations of international trade, analysis of development trends and dynamics of international trade
- Assessment of the significance of international transport corridors in the global economy and their prospects for the Uzbek economy; analysis of the impact of the global market situation on the economies of countries;
- to know the ways of effective organization of international business contracts and to apply them in practice.







**AT THE END OF THE EDUCATIONAL PROCESS, MASTERS SHOULD HAVE THE FOLLOWING SKILLS AND QUALIFICATIONS:**

- learning the scientific worldview's system of knowledge, as well as the basis of general methodological sciences and current state policy issues;
- to be able to apply economic principles to the effective use of production and labor resources in enterprises engaged in foreign economic activity;
- development and implementation of economic mathematical, informational, and simulation models on the subject of scientific research in the fields related to international economic relations;
- to have a full understanding of the processes and events happening in the world economy, so that they can be used in life, work, and modern scientific research;
- to have the ability to establish mutually beneficial agreements in the implementation of mutual cooperation with international economic organizations, integration groups, and foreign countries;
- knowing how to use information and pedagogical technologies in pedagogical activities;
- understand the innovative approach to improving educational quality and efficiency;
- having the skills to conduct scientific and applied research, process experimental results, draw scientifically based conclusions based on them, prepare and edit scientific articles, organize and conduct scientific seminars, conferences, and symposia, and develop scientific projects to be- have the skills to analyze the world market situation, segment the nomenclature of export goods, coordinate export and import contracts, adapt the composition of national goods and services to the requirements of world markets based on international standards, and classify indices in international goods, services, and financial asset markets to be;

- to actively participate in the development of diplomatic relations of our country, to work in embassies, consulates, and representative offices of foreign organizations, to have the ability to protect the interests of Uzbekistan;
- to have the ability to manage international contracts, find optimal solutions to transport corridors and logistics problems, and control the trade of goods and services;
- to be able to plan projects so they can join projects announced in the country and abroad that are based on the results of scientific work;
- to be able to prepare projects in order to participate in projects announced by state, non-state, non-profit, and international organizations.
- the ability to reach mutually beneficial agreements in the implementation of reciprocal cooperation with international economic organizations, integration groups, and foreign countries.
