

# BAHÁ'ÍS for INFORMED CHOICE



April 5, 2021

Dearly Esteemed Universal House of Justice Members:

We appreciate the sincerity with which you addressed your letter of April 1, 2021 to all LSA's and Bahá'í groups and fully appreciate and agree with the principals mentioned therein. However, as we know, the Guardian, Shoghi Effendi has advised us that as Baha'is we are not to isolate any single teaching of the Faith apart from the whole of the Writings. This makes communication on a global level, to a diverse population on a topic as complex as personal health and Covid, a formidable and challenging task. We will always be limited in a single letter due to the impossibility of considering all of our Faith's teachings. We seek clarification on other teachings of the Faith as well as offering additional medical perspectives from some of the leading doctors, universities, and health professionals in the world that can perhaps inspire future clarifications the Baha'i World Center may wish to send to the global Baha'i community in the days and weeks ahead.

We'd like to turn your attention to the following excerpts, starting with the letter of July 10, 2020 (The rest of this letter addresses the United States situation which may or may not apply to other countries):

*If a Bahá'í is faced with a governmental mandate of vaccination, the Bahá'í writings would not provide him or her justification for refusing to comply with such a legal requirement; therefore, a religious exemption could not be claimed.*

1. Bahá'ís and non-Baha'is alike have been promoting these covid-19 “vaccines” as if there is a mandate. In the United States there is no such legal mandate. Even were this so, no law (let alone a mandate) can circumvent the state or federal Constitution by denying medical choice—a very personal decision—which has been tested in the Supreme Court of the United States and reflected in the Geneva convention, the Nuremburg Code, etc. Further, these injections are not licensed or FDA approved, so US law states that they cannot be mandated and individuals have every right to refuse consent as they are experimental.
2. None of the Covid-19 “vaccines” are biologically or legally vaccines, which by definition must have an antigen, protect from infection, and protect from transmission. None of these “vaccines” fulfill any of these technical medical requirements as admitted in these companies' official documentation. They erroneously co-opted the term “vaccines” because then the mistakenly labeled vaccines are exempt from liability (see National Childhood Vaccine Injury Act of 1986). Additionally, if they were labeled correctly as experimental gene therapy treatments, other treatments would have to be allowed as well, which is not desirable to pharmaceutical companies who want to sell vaccines.
3. These vaccines have dangerous ingredients in them including polyethylene glycol (antifreeze) which causes cancer and severe allergic reaction and anaphalaxis, (@2900 times as reported by VAERS as of 3/19/21), and RNA which rewrites the individual's genetic code. Thousands of recipients of these vaccines have died in the U.S. alone ([openvaers.com/covid-data](https://openvaers.com/covid-data)). This is a crude passive count of the

serious adverse reactions, but the only system we have at present. The National Institute of Health and the Dept. of Health and Human Services in the US have reported that VAERS captures less than 1% of actual injuries.

Now we turn your attention to the letter of December 8, 2020 to this passage:

*In recent decades, advances in medical science have led to the production of effective vaccines, the use of which has freed humanity from many debilitating and deadly infectious diseases.*

1. There is no documented evidence that vaccines have cured disease. In fact, there are many books have been written proving the above sentence patently false. We recommend Dissolving Illusions by Dr. Suzanne Humphries and Roman Bystrianyk, a 200 year history of vaccines with over 700 references to government studies, propaganda, coverups, and criminal activities in which all major vaccine manufacturers have been complicit. All vaccine manufacturers have lost multiple criminal cases against them; the U.S. has the highest infant mortality rate of any developed nation and also the highest vaccination rate of any nation. Another fact that is often overlooked is that from 1900 to 1960, all infectious diseases decreased 99% WITHOUT vaccines. Improvements in sanitation, hygiene, and water purification were the causes. When vaccines were started on a national level, the pharmaceutical companies took the credit for this trend and the public was none the wiser.

2. Although the above quote may have been well-meaning, Bahá'í institutions are not qualified to give medical advice. In your letter dated December 8, 2020, it was stated that the Writings have no mention of vaccinations, but to refer to competent physicians. That same letter said that competent scientists would have to be consulted. Finally we were advised to “follow the counsel of medical and other scientific experts.” Does the Universal House of Justice fill any of these roles?

Now we'd like to turn your attention to the following passage in your letter of February 11, 2021:

*Responding through his secretary to a believer who had received conflicting medical advice, Shoghi Effendi once advised: “you should refer to other doctors, and follow the majority vote.”*

1. Shoghi Effendi's above advice was for roughly 100 years ago, and we know not if it was in regards to a vaccine. This is a very personal decision that needs independent investigation by the individual and is between the individual and his/her doctor. The whole medical landscape has devolved since then into a politically and financially driven industry, hardly what was intended by most people 100 years ago. Shoghi Effendi then was not addressing people of today or their circumstances.

2. Since when is following the majority a Bahá'í principal? Herd mentality should never be a Baha'i option as it is not consistent with the Arabic Hidden Word no. 2, and paragraphs 3, 4 and 8 of the attached February 11 letter, even stating “we are a religion and not qualified to pass on scientific matters.” and there is no obligation for the friends to have uniformity of thought (about them).” It goes against the principal of independent investigation of truth. Again, context is everything. Shoghi Effendi in his above communiqué was addressing one believer, not the whole world. That believer's circumstances must have warranted that particular advice. As Bahá'u'lláh writes: *We speak one word, and by it we intend one and seventy meanings; each one of these meanings we can explain.* Finally, in the attached February 26 letter, the final statement is “Ultimately, this is a matter for individuals to decide.” All these quotes seem to be inconsistent, confusing and not purely spiritual principles, for which we look to the Universal House of Justice.

The Bahá'ís who collaborated on this letter have collectively done over 10,000 hours of research on everything related to Covid-19. The depth and breadth of corruption behind the world-wide “pandemic” is too big a topic for now. Our concern is keeping Bahá'ís safe from the poorly untested experimental injections. These include more than 100,000 doctors and scientists worldwide that have signed petitions against the vaccines and the “pandemic” (See Great Barrington Declaration, [stopmedicaldiscrimination.org](http://stopmedicaldiscrimination.org), [petition.parliament.uk](http://petition.parliament.uk), and others).

There is no reason why Bahá'ís can't adopt a humble posture of learning and share differing points of view while respecting each other. It's a good practice in building our spiritual mettle which we will need to help usher in a new age of peace, love and unity.

We feel that a clarification to the Bahá'ís of the world in response to this letter would be greatly appreciated, especially since we are challenged with “the difficulty of attaining the truth, which seems to be an inherent characteristic of the process of disintegration that is assailing humanity in its transition to a new order.” Guidance to the Baha'i world can be adjusted as new information is revealed. Lives are at stake. Millions of them.
