NEPS NEWS: always print out the latest medication infusion order forms from NEPS when getting medication orders that are prescribed on paper forms. This will ensure that the most up to date dilutions and dosages are being prescribed for patients. Do not keep order forms in folders on the units- only use NEPS.

Here's a recap of the shared governance council meetings held on Wed 9/18/19 if you can't wait to read the minutes on our Phelps nursing website. A big thank you to all the nurses who participated. If your unit wasn't represented at each of the shared governance councils, please, please tell your nurse manager so that you won't miss another meeting. Our clinical nurses are energized, inspired, willing to help and mentor every nurse who chooses to join a unit or our Phelps shared governance council (and meet requirements for the career ladder). Unit shared governance councils should be meeting every month so that every clinical nurse has an opportunity to be involved and foster our professional growth.

Recruitment Retention and Recognition (RRR) Council

Every unit must have an "in the Moment" Star board to display nurse recognition by peers, patients and families. Please remember and keep track of all of your unit activities that are implemented to recognize nurses and support staff retention. We would like to present the first DAISY award in January 2020, so Elizabeth Perdomo-Benitez. RN recommended that we have a display (acrylic

holder for DAISY nomination information) and a locked box (to secure the nominations) that would be available on each unit. We have invited Marketing to our next meeting to help us "spread the word" regarding our DAISY recognition program. Ask Elizabeth if you have any questions about DAISY or the RRR council. **New Knowledge and Innovation Council**

Judy Kennedy, RN and Alicia Mulvena, RN invited Janice Lester (LIJ librarian), our external expert to help us learn more about searching the literature (e.g. accessing various databases, using PICO and key words). Janice and Peggy Tallier, EdD, RN helped us identify the next steps of each unit's evidence-based practice project and/or research study. As Peggy said, "it's much easier to break the EBP up into chunks and

work as a team", so if you are interested in starting an EBP on your unit, please remember this is the perfect forum to put your ideas in action. When you are ready to present your ideas at a conference, this is the place to share your results for peer feedback (to make it even better) and recognition.

Professional Practice and Development Council

Candice Johnson, RN chaired the meeting and brought Tahler Cambriello, RN, as part of succession planning. Candice willingly accepted the role as chair of this meeting but knew it would be too much to continue to chair her unit council. She is mentoring Tahler to assume chairmanship of the 5 North unit shared governance council. Donisha Sledge, RN shared her professional portfolio to help clarify the career ladder advancement (and sustainment) process. Following great feedback from the council members, Donisha offered to share her template with you if you are preparing to or ready to advance on the career ladder. Judy Dillworth, RN offered to meet and mentor any new or existing chairperson to successfully chair their unit council meetings. Please don't hesitate to email or call Judy (x3509). Council members reviewed the up to date unit certification data. Kathy Calabro displayed the data with every unit's certification rates. The nurses acknowledged each other and offered suggestions (e.g. provide certification review courses here at Phelps) to increase their unit's certification rates.

Ouality and Safety Council

Kathy Calabro presented each unit's data (NDNQI nurse-sensitive indicators: Falls with injury, HAPIs stage 2 and greater, CLABSI, CAUTI) for the most recent 8 quarters (3Q17-2Q19) compared to the national benchmark "all hospitals mean". A majority of our units outperform the benchmark a majority of the time. Congratulations to all! Phyllis Vonderheide, RN further recognized the nurses for excellent outcomes with patient satisfaction. When asked how we could be better, Phyllis explained that communication with nurses has the highest correlation with *overall* patient satisfaction. We (nurses) must always be aware of how patients would say RNs 1) treated you with courtesy and respect, 2) explain in ways you can understand and 3) listen carefully to you. Alex Xelas, RN reviewed select cases related to CLABSI and C-DIF in the 3rd qtr 2019. Clinical nurses shared other PI projects from their units.

CNO Advisory Council

Mary McDermott, RN, our CNO, praised the nurses for how well we are doing with the telesitter monitoring program in just one month. Clinical nurses are empowered to identify patients for enhanced supervision and select patients who would benefit from the telesitter. More techs are available to help with direct patient care for more patients when the telesitter is used. Thanks to all nurses for making this program a success from the very start. Mary said that additional staff (5 techs, 5 HUC positions) were hired to support our nurses. Mary shared the responses of questions taken from the NDNQI nurse satisfaction survey. The clinical nurses gave Mary valuable feedback and great suggestions which Mary is considering. The clinical nurses remarked that it is important to be involved. They felt that by attending these shared governance council meetings, their voices are being heard.
