## **Infection Control and Prevention:**

\*On July 16, 2021 **The New York State Health Department released a Health Advisory for Legionellosis.** Medical provider recognition of the possibility of Legionnaires' disease (in persons with pneumonia), Pontiac fever (in persons without pneumonia) or Extrapulmonary Legionellosis (in persons with Legionella in sites outside of the lungs) coupled with **appropriate diagnostic testing** is critical to the identification and investigation of community clusters.\*

### Remember to obtain a urine and a sputum concurrently when testing patients for Legionella.

### **Medication Safety:**

- When a patient is ordered IV fluids and / or medications and is going to the Operating Room or other procedural area, please continue the fluids; **do not stop** the fluid administration. If fluids are stopped without an order, the RN stopping the fluids is non-compliant with the physician order.
- If a patient is admitted with continuous administration of a medication through a port, for instance chemotherapy, please ensure that there is an order to continue administration of that medication or discontinue it.

### **Blood Transfusions and Transportation of Patients:**

For any patient with blood or blood products actively infusing, if the patient needs to be transported off the unit, **they must be accompanied by an RN**, NP, Physician or PA.

In addition, the patient may not be transported within first 15 minutes of transfusion, until second set of vital signs are complete, unless an emergency exists.


