Injury with Falls - Adult Psychiatric (1S)



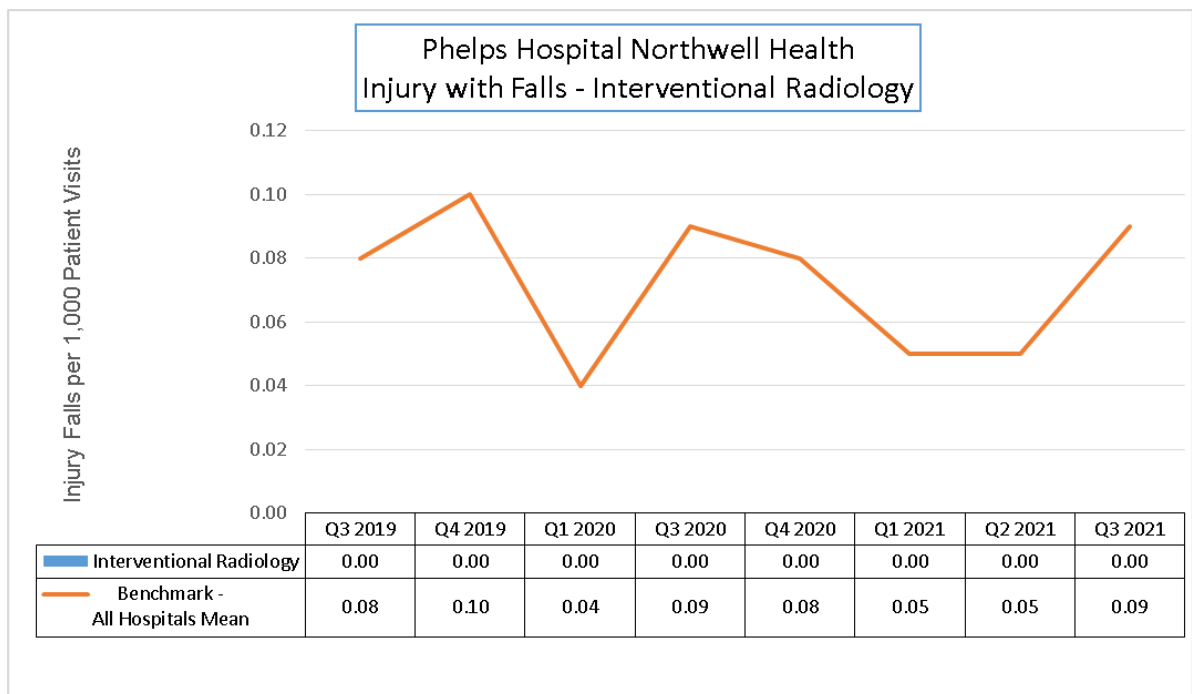
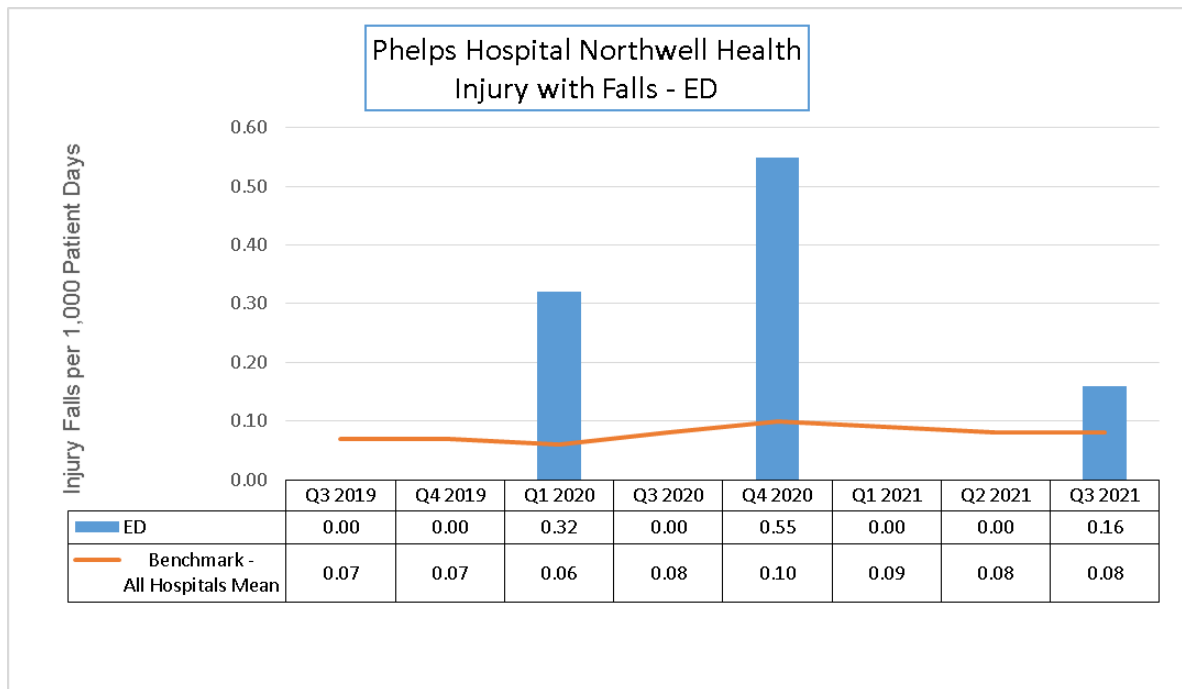

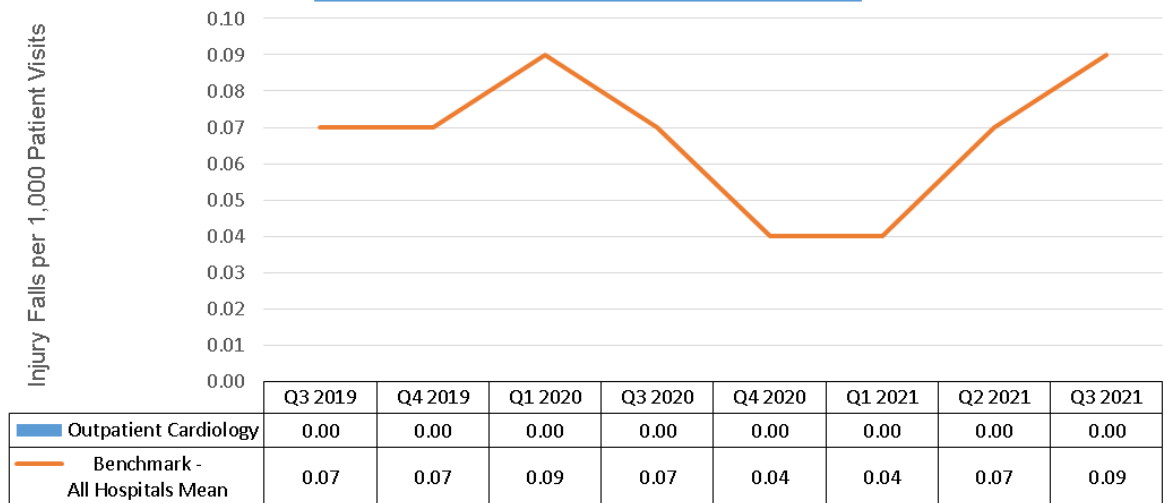

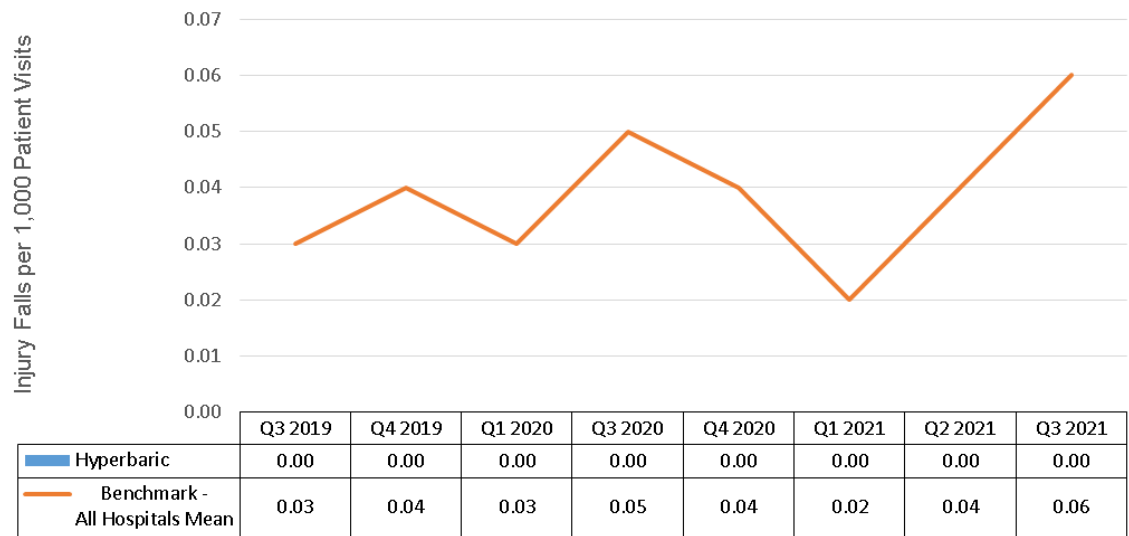

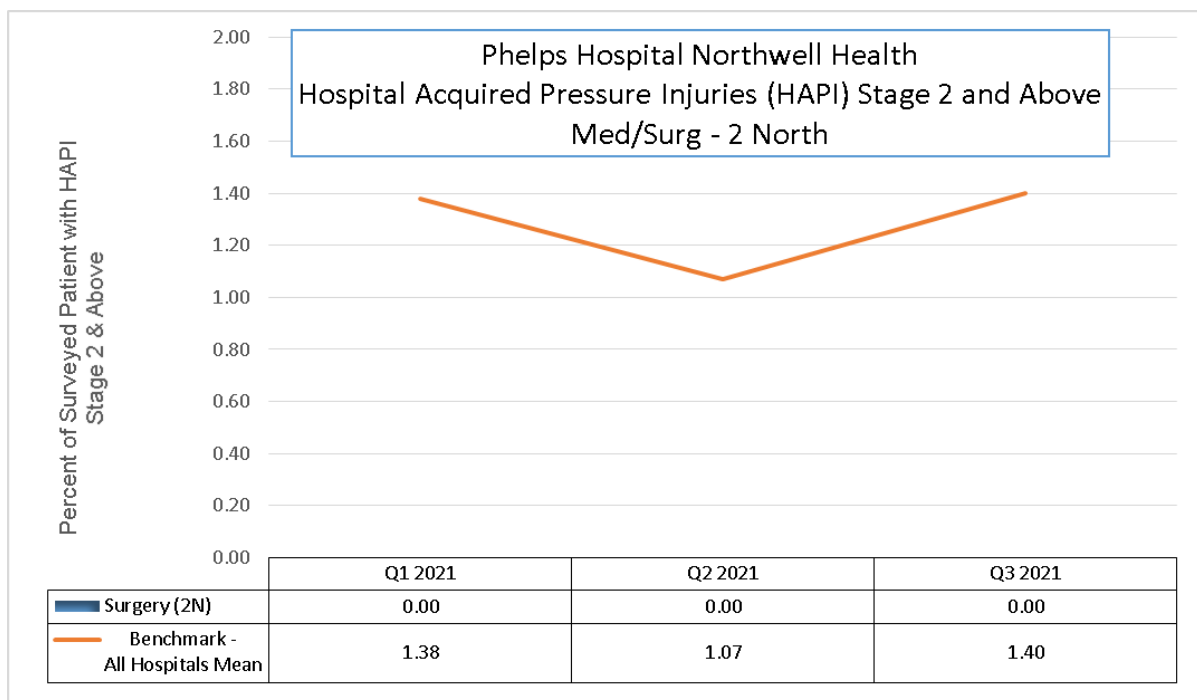
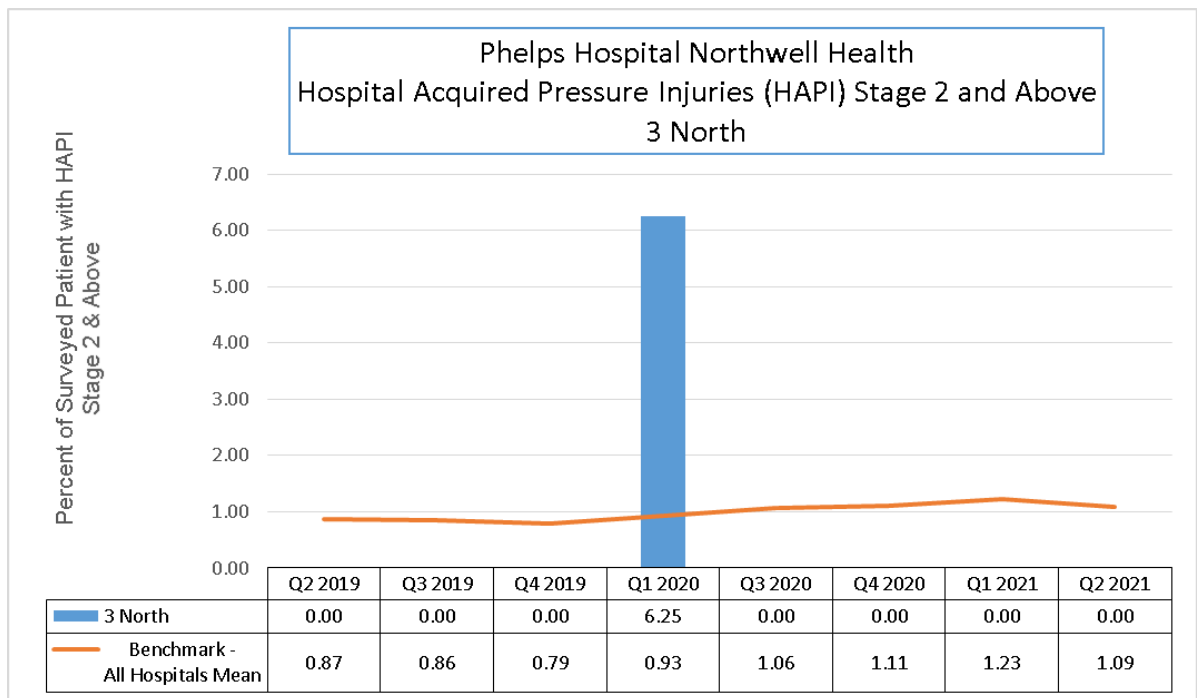
Percent of Surveyed Patient with HAPI  
Stage 2 & Above



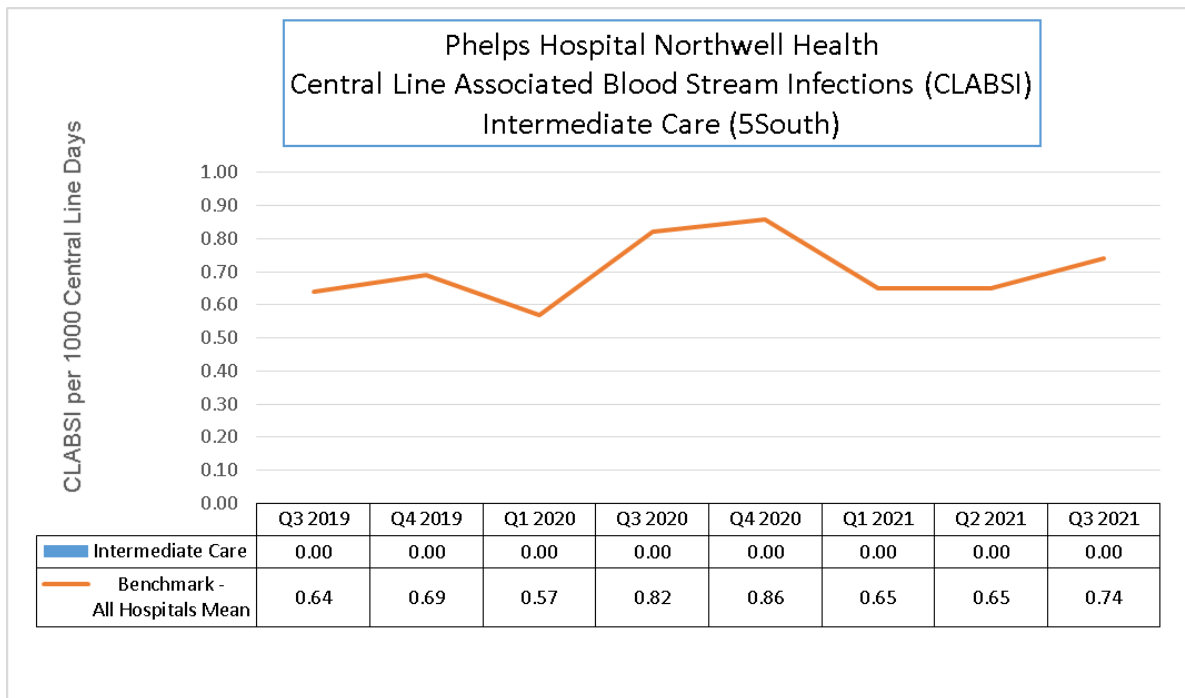
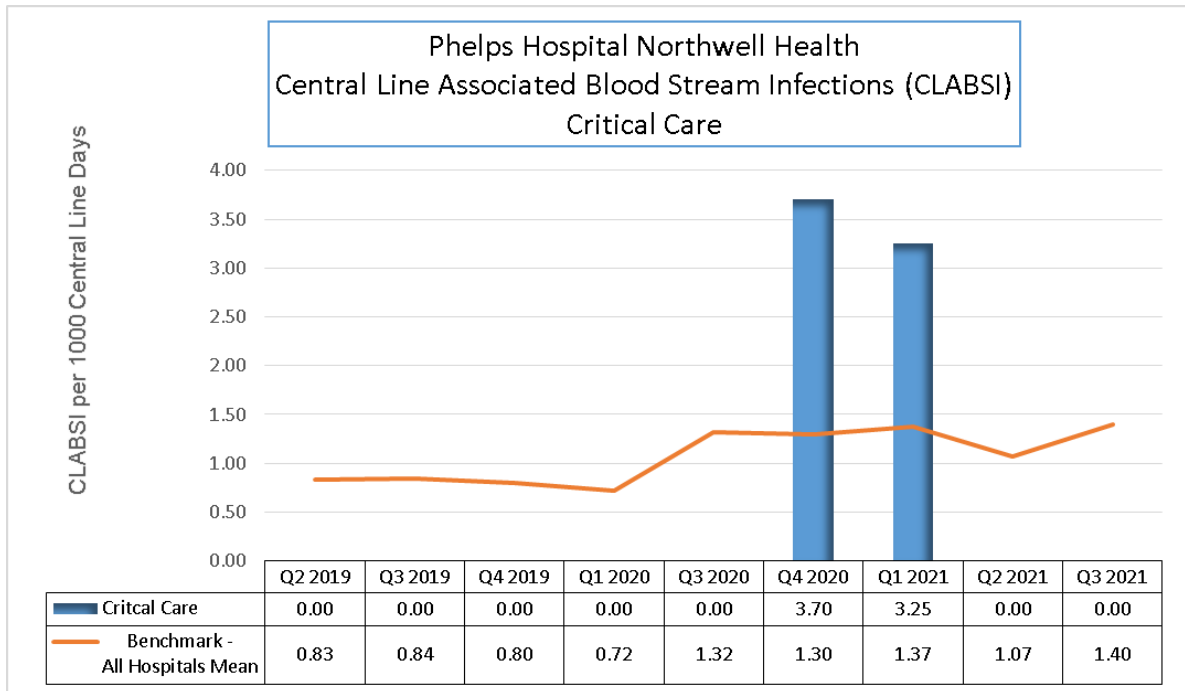
