COMPETITION PROCEEDINGS (The Preliminaries → The Finals)

STEP 1	Apply to the Preliminaries by submitting iCAN 2021 Application Forms by email				
STEP 2	The jury committee evaluates all submitted application forms to select winners of the Preliminaries Awards (Gold/Silver/Bronze Awardees are decided in this stage)				
STEP 3	Winners of the Preliminaries become Finalists who are eligible to compete in the Finals (Advancing to the Finals is an optional choice for the Preliminaries winners)				
STEP 4	Finalists proceeding to the Finals are required to submit video presentation files for their inventions. Video file submission instructions will be provided to them.				
STEP 5	The jury committee evaluates all video presentation files to select the winners of the Finals Awards (Special Awards / Best Invention Awards / Semi / Grand Prize)				
STEP 6	The Finals Award Winners Result will be announced on iCAN webpage on August 28th				
STEP 7	The Finals Movie & Keynote Presentations will also be available on August 28th				
STEP 8	The Preliminaries & the Finals Award Packages (award certificates, medals, directory handbook, event souvenir items) will be shipped by international airmail after the Finals

UNDERSTANDING 2 STAGES OF ICAN 2021

- 1) THE PRELIMINARIES (required): initial participation by submitting application form
- 2) THE FINALS (optional): additional participation by submitting invention video file

STAGE 1: THE PRELIMINARIES (All Applicants)

Step 1: Fill Out Your iCAN 2021 Application Form

- Complete 1 Application Form for each invention/project
- Make sure to fill in all required fields in the "Personal Information" Section
- Provide both written description & visuals (photos, diagrams, screenshots, etc.)
- Incomplete application forms are subject to automatic disqualification

Step 2: Submit Your Application Form by Email

- Submit the completed application form to ican@tisias.org by no later than June 15
- Receive a confirmation email back from the organizer after your submission
- You will then receive Preliminary Result for Gold/Silver/Bronze on or before July 1
- You are now a Finalist able to submit the video presentation for the Finals (optional)

STAGE 2: THE FINALS (Qualified Finalists from the Preliminaries)

Step 1: Decision to Submit the Optional Video Presentation for iCAN 2021 "The Finals"

- Finalists have the choice to submit their invention/projects' **video** presentations
- The video presentation files will be used for an additional evaluation process by the jury
- The jury will choose the Finals award winners among the video-submitted Finalists
- The Finals Award Winners will be announced on August 28th on website/social media

Step 2: iCAN 2021 "The Finals" | Announcement of the Finals Winners & Movie Showing

- iCAN 2021 "The Finals" Movie will be displayed on website/social media/YouTube
- The Finalists' submitted videos/photos will be used for judging and making the movie
- After the Finals, all participants will receive their Award Packages by express airmail
- All award winners will be asked to send a photo taken together with the awards
- iCAN 2021 Group Photo Collage will be produced and shared with all participants







VIDEO PRESENTATION GUIDELINES

The videos can be created using various methods of your choice and creativity

- Video Length: limited to less than 5 minutes playtime (Max. Length: 5 minutes)
- Presentation: facial/oral presentation, PowerPoint & voice, video editing/mixing is allowed
- File Format: horizontal widescreen in any file format (.MP4, .WMV, .AVI or .MPEG.)
- Submit By: Email Attachment / Google Drive / YouTube Link / Dropbox / Mega File, etc.

COMPETITION RULES SUMMARY

- All applicants must initially submit an application form (1 for each invention/project) by email to <u>ican@tisias.org</u> to participate in the iCAN 2021 Preliminaries.
- Selection of Preliminaries Winners for Gold, Silver & Bronze Awards is determined based on the submitted application form via screen evaluation and winners are qualified for the Finals.
- Finalists are eligible to **submit video presentations** to compete for the Finals Awards.
- Submitting video presentations is an optional choice for the Finalists; they will still receive
 their Preliminary Awards (Gold/Silver/Bronze) by airmail without having to submit the
 video presentations only if they wish to not compete for the Finals Awards.



TERMS AND POLICIES + ADDITIONAL INFORMATION

- Applicant's failure to correspond with the organizer via email communication for necessary confirmations may lead to natural cancelation of their applications from the competition.
- Applicant's failure to pay registration fee invoiced before the specified due date may result in incompletion of registration and eventually lead to disqualification from the competition.
- Finalists' **invention presentation videos** will be used by the organizer to generate **the Finals Movie** and it may have limited showing of each clip depending on the quality of the videos.
- iCAN 2021 Award Packages will be shipped by international express airmail only for those participants who have completed their invoice payment & fulfilled registration requirements.
- Finalists can send a photo of themselves taken together with their inventions, products, or projects to be included in the video and other future contents of iCAN promotions.
